**Brief Description/Background:** IFB 20-15 Deer Canyon Road Reconstruction was solicited on October 22<sup>nd</sup> 2020, and sealed Bids were opened on November 19<sup>th</sup>. There were 3 (three) bids received from Renegade Construction, J&H Services, and Constructors. Bidders were asked to provide a total amount for the FEMA reconstruction of the above referenced road.

The lowest overall bid was submitted by J&H Services Inc. The bid was considered responsive, and therefore, the Public Works Department Head and the Procurement Manager are recommending award of IFB 20-15 be made to J&H Services Inc with a total responsive bid of \$283,717.92.
